# 1. Pledge of Allegiance

#### 2. Executive Directors Report

Mr. Zeuner noted that Lauren Gallagher and Noah Marlier from Rudolph Clarke's office and that they were in attendance for an executive session to discuss matters of litigation regarding Schenk vs. the Authority. Mr. Zeuner reported that due to the extreme cold weather we did have a water main break on Autumn Drive on Tuesday, January 7<sup>th</sup>, and that is has been repaired.
