2. Executive Directors Report

Mr. Zeuner gave an update on the following topics:

3. Citizens' Concerns

Mr. David Lauer of Cornell Ave, had concerns regarding his sewer bill and placing a meter on his well. He stated he waters his shrubs and does not feel he should pay sewer charges on that water. Mr. Zeuner and Mr. Albano explained the Rates, Rules and Regulations to Mr. Lauer and stated we must treat all customers with the same Rates, Rules and Regulation. 4. Approval of the Minutes of September 17, 2014

5. Check Requisitions / Accounts Payable
